### **General**

#### **1**

The Westsächsische Hochschule Zwickau and Kyrgyz-German Institute of Applied Informatics, INAI.kg agree to cooperate in their mutual interest for a range of higher education activities, including

- courses, teaching cooperation
- movements of students, exchange of students
- cooperative research projects

#### **2**

The academic cooperation between both institutions will strengthen the partnership and relations between Germany and Kyrgyzstan and increase the mutual understanding of working and living conditions.

#### **3**

Both universities agree to cooperate in their mutual interest for a range of higher education activities. In doing so, specific projects and programs will be set up by the respective faculties thereby concentrating on:

- a. exchange of students
- b. exchange of teaching staff
- c. jointly organized units of study
- d. jointly organized research and development projects

They are objects of further agreements.

4

Both universities support the cooperation depending on their capabilities and resources. In order to be able to organize, implement and execute projects both universities agree to seek for additional funding provided by national and international organizations and funding agencies.

5

It is understood that each university will sufficiently support professors, students and other members of staff who participate in exchange programs. This particularly refers to the organization of the stay abroad, the journey to the respective country, the conditions of stay and the organization of the academic program for exchange students.

Each participant is responsible for taking out their own individual health, accident and liability insurance. Prior to the stay abroad, each participant is furthermore responsible for gathering information about the terms and conditions of insurances, in particular health, accident and liability insurances. As far as the exchange of students is concerned, the respective additional agreement applies.

In order to be able to provide all necessary documentation and confirmations, the host university will support guests in visa-related matters. Please note that participants are individually responsible for applying and paying for a visa and possible fees.

The agreement is available in English.

7

This agreement will come in force after the approval of the academic bodies and the signing of the legal representative. It can only be changed in writing and after mutual agreement. The agreement shall be effective for a period of five years from date of signing. Both parties reserve the right to cancel the agreement. A cancellation must be in writing and with at least six months' notice before the date of expiry.
